Jimoto Holdings, Inc. (the "Company") hereby announces, with sincere apologies, the partial withdrawal and revision of one of the proposals to be submitted to the 12th Annual General Meeting of Shareholders and the General Meeting of Class Shareholders of common shareholders of the Company, as described below

The "Notice of the 12th Annual General Meeting of Shareholders and the General Meeting of Class Shareholders" posted on the websites of the Company and the Tokyo Stock Exchange today represents the content before revision. A notice containing the revised content will be posted on each website in the coming days.

1. Proposal to be partially withdrawn

The proposed candidacy of Ken Shibata (candidate number 9) and Hideki Nishizuka (candidate number 10) for Director under Proposal No. 2 "Election of 13 Directors (Excluding Directors Who Are Audit and Supervisory Committee Members)" to be submitted to the 12th Annual General Meeting of Shareholders and the General Meeting of Class Shareholders of the Company (the "General Meeting")

2. Reason for the partial withdrawal

The Company nominated 13 candidates for the positions of Directors (excluding Directors who are Audit and Supervisory Committee Members). However, this will result in the number of Directors, including the three candidates who plan to resign to take management responsibility for the substantial losses incurred and the non-payment of dividends over two consecutive fiscal years, temporarily exceeding the maximum number of Directors stipulated in the Company's Articles of Incorporation (up to 12 Directors). Therefore, the Company will withdraw the two candidates above.
